



Financial Aid Application

There is a limited amount of funding for Summer Science financial aid. Aid is awarded on the basis of household income and is awarded in the order that completed financial aid applications are received until scholarship funding is exhausted. Eligibility and aid award is based on the US Department of Housing and Urban Development's income limit categories. Financial Aid will be 75% of the camp tuition for families that have adjusted gross income equal or less than 30% limits (30% of the median income for the area of residence). Families with more income, but which meet the test for Very Low Income will receive 50% of the camp tuition in aid. Please go to <http://www.hud.gov/offices/cpd/affordablehousing/programs/home/limits/income/2010/> to view the most current eligibility information. If there is more current information on HUD's site at the time financial aid applications are reviewed, we will use the current information. *No person shall be denied or receive Financial Aid on the basis of race, religion, national origin or sexual preference.* All information provided will be maintained confidentially.

The deadline to apply for Financial Aid is June 1, 2011. However, most camps have limited enrollment and registration is not complete until payment is received in full. To ensure your child is enrolled you can either:

- 1) **Register online and pay the full camp tuition and submit your financial aid application before the deadline.** If financial aid is awarded you will receive a payment for the amount of aid granted.
- Or
- 2) **Email or fax your Financial Aid Application NOW, with authorization for your credit card to be charged for your portion of the camp tuition.** We will manually enroll your child in the camps you select.

Please fill out this form completely. Submit one application for each child you would like to register and return it along with the first pages (first page of 1040EZ, first 2 pages of 1040) of your most recent federal income tax return. One tax return per family will suffice. We do not need any of the supplemental schedules if you itemize. If you have filed for an extension, please submit the 2008 tax return plus current pay stubs or some other form of income verification.
